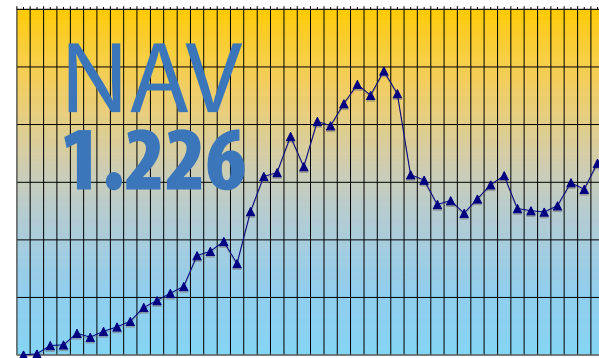

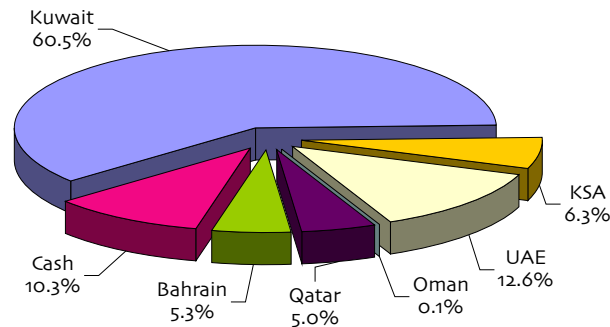

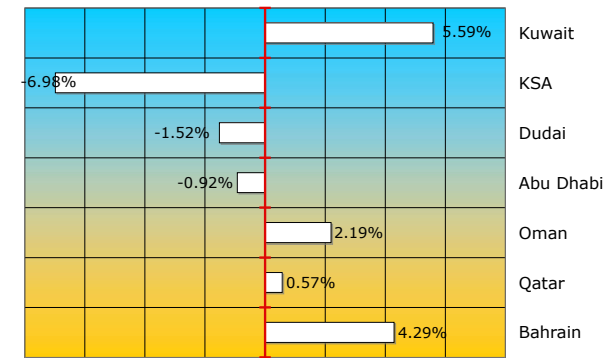

GCC Market Performances - Jun'07



Market Review:

Most of the GCC region's equity markets rallied during June, led by Kuwait which gained +5.59% followed by Bahrain +4.29%, Oman +2.19% and Qatar 0.57%, Part of the increase was seasonal, driven by the expected strong profit announcements for the first half of the year. On the other hand Saudi, Dubai and Abu Dhabi witnessed a decline for the month -6.98%, -1.52% and -0.92% respectively.

Fund Review:

Al-Ahli Gulf Fund recorded a NAV of K.D 1.226 for the month of June with a return of +90.18% since inception, and a gain of 0.41% on month-to-month basis, due to the increase in 4 out of 7 GCC markets.

The fund asset allocation in the GCC markets is as follows: Kuwait 60.51%, UAE (Abu Dhabi & Dubai) 12.63%, Saudi 6.31%, Bahrain 5.26%, Qatar 4.97% and Oman 0.14%. The fund finished the month with 10.25% in cash.

The fund management team still believes that selected sectors and stocks in the GCC markets present a good case for stock accumulation. Moreover, the GCC markets are expected to consolidate after the first half of 2007 as investor expectations start to moderate and valuations appear more reasonable since corporate earnings growth is likely to remain on track. However, political tensions in the region will continue to remain a concern.
