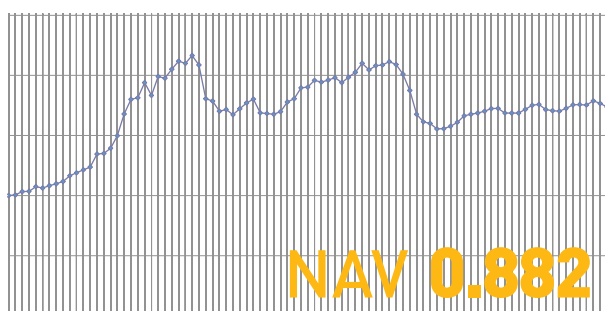

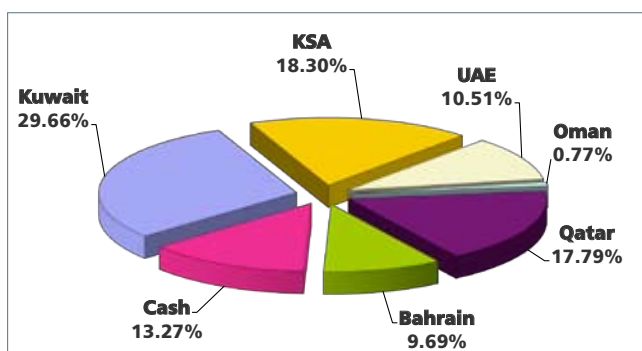

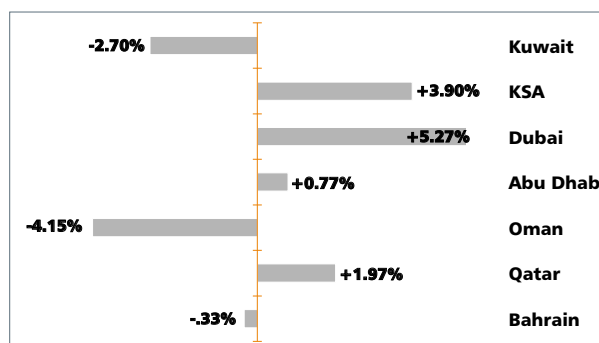

GCC market performance - Mar'11



Market review:

The GCC markets had a mixed performance during March. For the month the KSE was -2.70%, Saudi +3.90%, Dubai +5.27%, Abu Dhabi +0.77%, Oman -4.15%, Qatar +1.97%, and Bahrain -0.33%.

During the month some of the markets rebounded significantly, after a going down sharply in the early part of the month. This was due to investors realizing that market fundamentals are still strong and that political dynamics of the GCC countries are unique and different from the rest of the MENA region which has witnessed great unrest. Several high profile development plans and incentives announced by Saudi and other GCC governments acted as catalysts for the recovery.

Fund review:

The Al-Ahli Gulf Fund recorded a small gain of +1.048% MTD and -4.573% YTD. The S&P GCC Composite Price Index was +2.00% MTD and -3.69% YTD mainly due to the Saudi weight factor of the index. The Gulf Funds gain since inception stood at +74.732%, the NAV of the fund was KD 0.882319 on the NAV date.

The fund manager shall continue to take into account the volatility of the region as a whole in deciding the asset mix and cash percentages this approach in turn has and will continue to reflect on the Fund's overall future performance. The current GCC allocations remain stable with a selective allocation of Blue Chip stocks across the region. The fund holdings are constantly monitored for the various risk factors by our investment team and appropriate action to rebalance the country allocation, cash percentages, as well as sector allocations is taken when needed.
