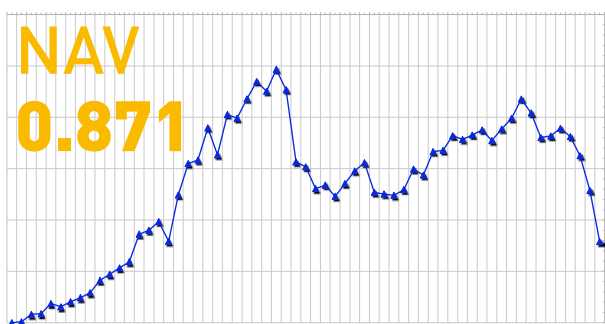

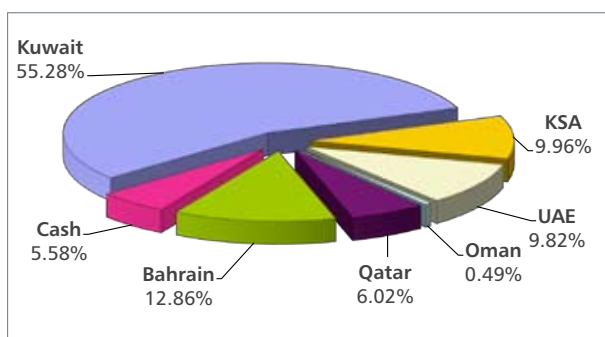

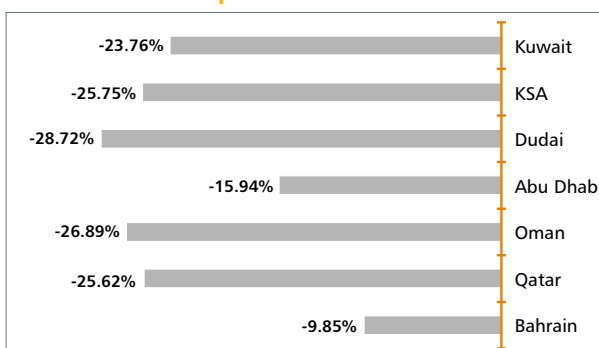

GCC market performances - Oct'08



Market review:

All of GCC markets exhibited negative performance in October 2008. Saudi's stock market was (-25.75%). The KSE market registered (-23.76%). The Omani market recorded (-26.89%), Bahrain recorded (-9.85%), Qatar (-25.62%), Dubai (-28.72%) and Abu Dhabi's market by (-15.94%).

This decrease was driven by the market makers while there was a problem with the real estate mortgage and the shortage in cash.

Fund review:

Due to the loss reported by the GCC markets, Al-Ahli Gulf Fund achieved a loss of (-18.56%) on the MTD basis and recorded a NAV of KD 0.871 for the month of October, (-23.53%) on YTD and (+67.64%) since inception.

The fund management team believes the GCC markets are under stable positive trend, which is a consequence of the strong profit announcements.

The GCC portfolios remain stable with an allocation of Blue Chip stocks across the region and stock selection is based on strong financial backgrounds and stable operational profits.
