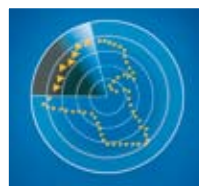

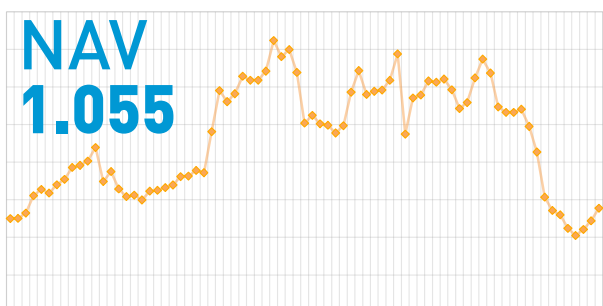

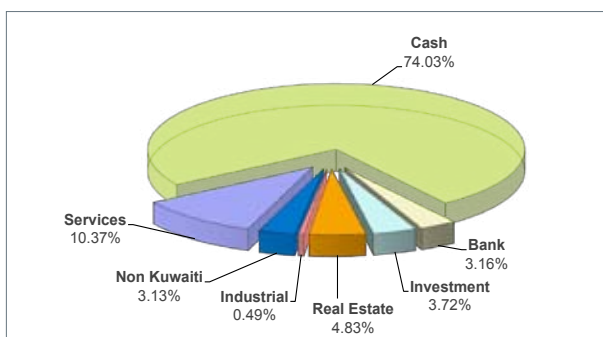

## Market review:

The Kuwait Stock Exchange ended the month of May 2009 on a positive note the third positive month so far this year. The KSE price index was up +7.85%, closing at 8,150 points. The KSE weighted index increased by +11.11% ending at 439.78 points.

High volumes and positive investor sentiment pushed up all the sectors on the KSE. Banking +6.16%, Investment +6.36%, Insurance +5.0%, Real Estate +9.55%, Industrial +6.4%, Services +15.76%, Food +12.8% and the Non-Kuwaiti sector +3.25%.

The daily average Volume and average value of shares traded on the exchange for the year was 493.18 million shares and KD 91.6 million respectively. Total Market Capitalization stood at KD 34.603 Billion at the end of the month.

The Price Index achieved a month high of 8,138.4 points on the 31st of May.

## Fund review:

During May, the fund and comparable indices all performed positively with the funds returns touching +6.73% MTD and +3.5% YTD as compared to the KSE weighted index which recorded +11.11% MTD and +8.13% YTD, and its benchmark the KIC index that recorded a gain of +11.54% MTD and +3.68% YTD

The fund team continues to believe that the market would reward the blue chip companies with substantial operational earnings, and that would in turn reflect on the Fund's overall future performance. We believe that a more careful stock selection criteria needs to be adopted since the markets are showing signs of high speculation and volatility in certain stocks. The fund holdings are constantly monitored for the various risk factors by our investment team and appropriate action to rebalance the country allocation as well as sector allocations is taken when needed.
