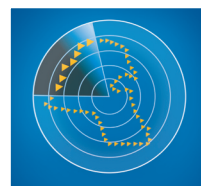

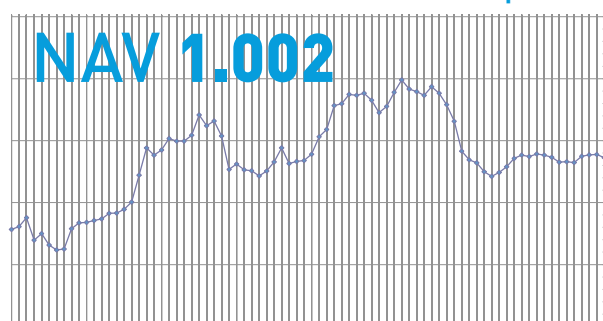

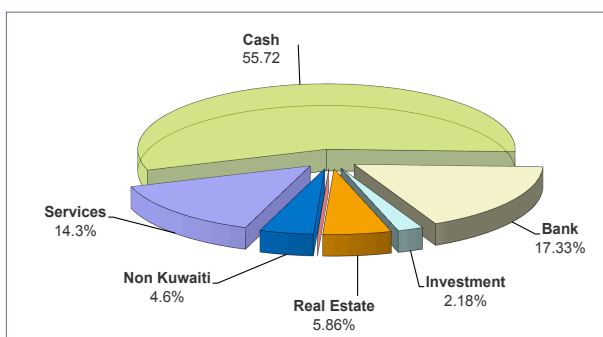

Market review:

The Kuwait Stock Exchange on the Funds NAV date 26th of May 2010 closed in the Red. The KSE price index was -6.74% MTD and -2.83% YTD, closing at 6,807.3 points while the KSE weighted index decreased by -5.85% MTD and was up +6.33% YTD, ending at 410.17 points.

The sectors on the KSE moved as follows, Banking -3.26%, Investment -5.65%, Insurance -2.69%, Real Estate -5.67%, Industrial -5.89%, Services -3.95%, Food -4.32% and the Non-Kuwaiti sector -8.67%.

The daily average Volume and average value of shares traded on the exchange for the year was 404.06 million shares and KD 67.10 million respectively. Total Market Capitalization stood at KD 32.03 Billion.

The Price Index achieved a month high of 7,311.7 points on the 3rd of May.

Fund review:

During May, trading activity was very poor with low volumes and extreme investor negativity. The market in general was very bearish. Investor confidence was eroded with the problems in the euro zone and its impact on the global economy in general. The prices of crude oil witnessed corrections as well.

The Al Ahli Kuwaiti fund performance was -2.45% MTD and +3.25% YTD as compared to the KSE weighted index which was -5.85% MTD and +6.33% YTD, and its benchmark the KIC index that recorded -5.53% MTD and +5.38% YTD.

The fund managers constantly take into account the volatility of the stock market as a whole in deciding the asset mix and cash percentages in this volatile period, this approach in turn has and will continue to reflect on the Fund's overall future performance as can be seen in the reflective performance above. We believe that an extremely careful stock selection criteria needs to be continuously adopted in the coming periods with risk aversion at its peak. The fund holdings are monitored regularly, various risk factors are taken into account by our investment team and appropriate action to rebalance both stock and cash allocations is taken when needed.
