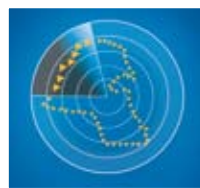

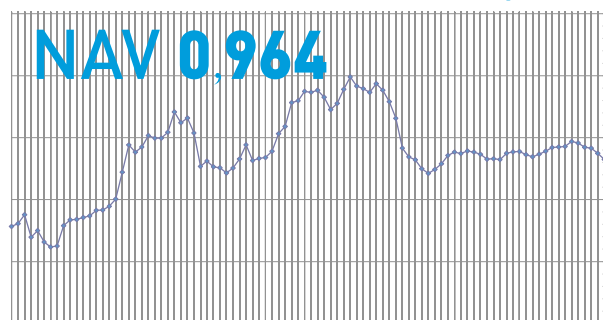

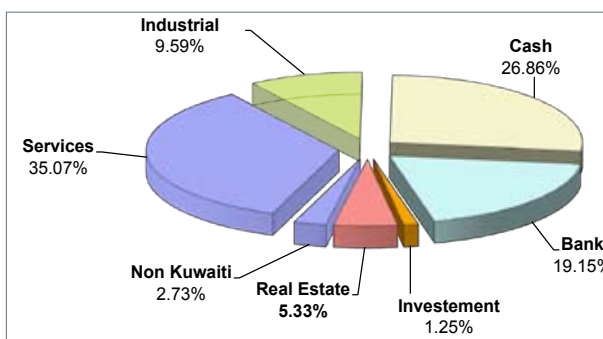

Market review:

The Kuwait Stock Exchange on the Funds NAV date 25th of May 2011 closed negative. The KSE price index was -1.84% MTD and -8.42% YTD, closing at 6,369.60 points while the KSE weighted index decreased by -4.60% MTD and -8.65% YTD, ending at 442.27 points.

All of the sectors on the KSE moved downwards except the Insurance, Banking -1.65%, Investment -2.82%, Insurance +0.38%, Real Estate -1.47%, Industrial -3.66%, Services -6.19%, Food -0.76% and the Non-Kuwaiti sector -2.31%.

The daily average Volume and average value of shares traded on the exchange for the year was 1905.55 million shares and KD 33.07 million respectively. Total Market Capitalization stood at KD 32.073 Billion.

The Price Index achieved a month high of 6,537.5 points on the 11th of May.

Fund review:

The Kuwaiti stock market took a large hit this month and the correlation was throughout the GCC region. Kuwait got its new cabinet during the month and protests against the new cabinet by Members of parliament have caused lots of uncertainty with continuous Friday protests. These factors have been compounded with the region Arab issues in Syria and Libya. The fund managers still feel that on Fundamentals there are several stocks at a deep discount however the general sentiment or rather lack of investor confidence has caused downward pressure on the markets.

The Al Ahli Kuwaiti fund performance was -4.80% MTD and -5.61% YTD as compared to the KSE weighted index which was -4.60% MTD and -8.65% YTD, and its benchmark the KIC index that recorded -4.34% MTD and -12.23% YTD.

The fund managers constantly take into account the volatility of the stock market as a whole in deciding the asset mix and cash percentages in this volatile period, this approach in turn has and will continue to reflect on the Fund's overall future performance. We believe that an extremely careful stock selection criteria needs to be continuously adopted in the coming periods with risk aversion at its peak. The fund holdings are monitored regularly, various risk factors are taken into account by our investment team and appropriate action to rebalance both stock and cash allocations is taken when needed.
