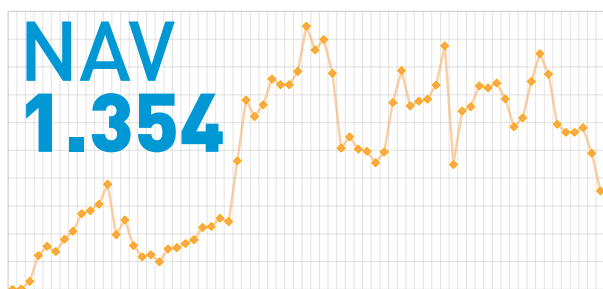

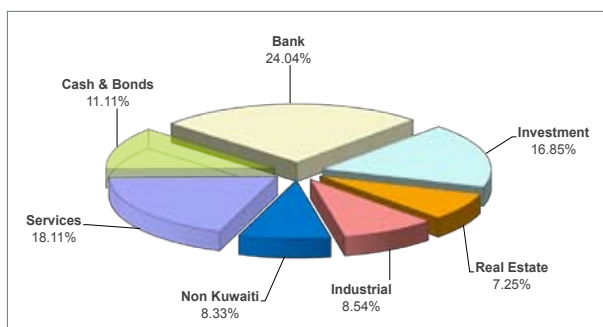

Market review:

Kuwait Stock Exchange ended the month of September 2008 in a negative performance. The KSE price index recorded (-3.59%) growth and closing at 12,379 points. As for the KSE weighted index, It decreased (-4.35%) to reach (+ 620.01) points during this month.

Broad-based strength pushed down all of the KSE sectors. The Real Estate Index recorded (-4.29%) The Industrial index recorded (-2.76%) the Insurance index registered (-2.24%). And the Banking sector recorded (-3.62%) and the Non-kuwaiti index recorded (-4.21%) and the Investment Index recorded (-3.83%), and the Services Index recorded (-4.08%). Finally the food sector that recorded (-1.99%).

The daily average Volume and daily average Value of shares traded on the exchange was 342.73 million shares and KD 158.33 million respectively. Total Market Capitalization stood at KD 51,009 million by month end.

The Price Index achieved a high record during the moth of August reaching 14,427.6 points on the 1st of September.

The Price Index continued to be higher than the weighted Index during this month, due to the modest activity on leading shares of the market and increased activity on the small and medium market cap shares.

Fund review:

During September, the fund accomplished a negative performance where the NAV decreased to (-7.39%) YTD as compared to the KSE weighted index which recorded (-13.29%). In addition, the Fund outperformed its benchmark the KIC index that recorded a loss of (-19.5%) for the YTD performance.

Significantly, the negative growth is mainly attributed to the concentration of the fund in the Real Estate, Services and Investment sectors, which improved weak performance.

The fund team continues to believe that the market would reward the blue chip companies, with substantial operational earnings, and that would In turn reflect on the Fund's overall portfolio performance.
